

KJOY 98.3's TRIP GIVEAWAY MARCH 2025

OFFICIAL CONTEST RULES

KJOY 98.3 hereinafter referred to as the "Station"

No purchase or payment is necessary to enter or win this promotion. A purchase or payment of any kind will not increase your chances of winning. By participating, each entrant fully and unconditionally agrees to be bound by and accepts these official Contest Rules.

1. Promotion Dates

The station, owned and/or operated by Connoisseur Media, LLC (CONNCO) is running a promotional contest (the "Contest") from on or about January 27, 2025 at 12:00 am EDT until on or about February 28, 2025 at 11:59pm EDT (the "Promotion Dates"). Grand Prize winner will be announced on or about March 28, 2025.

2. Entry / How To Win

- a. *Potential qualifiers will listen to WKJY-FM (KJOY 98.3) during the "contest" promotional period and listen for the TEXT CODEWORD announcement around 6:10 AM, 7:10 AM, 8:10 AM, and 9:10 AM Local Time every weekday throughout the contest period.***
- b. *When the song mentioned in that specific hour's announcement plays in that specific hour, that is the prompt to text the specific word that is identified in that specific announcement to 631-955-WKJY (9559). One text entry per announcement event will be eligible as a qualifier for the grand prize.***
- c. *As an ALTERNATE method of entry, ONE physical entry form may be obtained by sending a self-addressed stamped envelope to KJOY 98.3 Trip Giveaway March REQUEST c/o Connoisseur Media Long Island 234 Airport Plaza Blvd. Suite 5 Farmingdale, NY 11735. One entry per person using this method will be valid. This is specifically to be used as an alternative method of entry. Duplicate entries that include a physical entry form will be disqualified.
